



CONTINUOUS* and EXTENDED USE** PPE GUIDELINES when caring for Residents suspected or confirmed to have COVID-19 in Continuing Care

* [Continuous face mask use](#): all healthcare workers who come into contact with patients during the course of their shift must wear a face mask at all times

** Extended use of face masks¹ and eye protection²: is the practice of wearing the same face mask and eye protection for repeated interactions with multiple patients for the maximum of one complete shift

- **NOTE:** The PPE requirements outlined in this guideline may need to be modified to reflect the differences in the physical layout and type of activity performed by staff within these testing and assessment sites. Any modifications to the PPE requirements must be based on a point of care risk assessment and using professional and clinical judgement.

		Providing care to residents (Aerosol generating medical procedure [AGMP] performed)	<ul style="list-style-type: none"> • N95 respirator (fit-tested, seal checked) • Eye Protection • Gown • Gloves 	<ul style="list-style-type: none"> • N95 respirator: Extend use for multiple AGMPs. Change N95 respirator IF it becomes wet, damaged, or soiled. Discard when taking a scheduled break and at end of shift • N95 respirator: Extend use for single AGMP. Change N95 respirator IF it becomes wet, damaged, or soiled. Discard when taking a scheduled break and return to continuous mask use guidelines • Eye Protection: Remove/disinfect before a scheduled break and at the end of shift. Discard face shield at the end of shift • Gown and gloves: Change between each resident encounter • Perform hand hygiene according to SHA Hand Hygiene Policy

Resident Transport Outside Room	Transporter(s)	Assisting with transport of resident	<ul style="list-style-type: none"> • Face Mask • Eye Protection • Gown • Gloves <p>NOTE: Have resident wear a mask if able to tolerate</p>	<ul style="list-style-type: none"> • Mask: Change IF it becomes wet, soiled, or damaged. Discard when taking a scheduled break and at end of shift • Eye Protection: Remove/disinfect before a scheduled break and at the end of shift. Discard face shield at the end of shift • Gown and gloves: Change between each resident encounter • Perform hand hygiene according to SHA Hand Hygiene Policy

Entire Facility	Other Staff (not listed in this table)	Any	<ul style="list-style-type: none"> • No PPE required or PPE as per Point of Care Risk Assessment 	<ul style="list-style-type: none"> • Perform hand hygiene frequently • Note: <i>comment on non-medical masks</i>³

¹**Face mask** defined as a procedure or surgical mask
