

HUMBOLDT DISTRICT HEALTH COMPLEX FACT SHEET

The facility will replace the Humboldt District Hospital, formerly St. Elizabeth's Hospital on a new site at the north end of Humboldt. The hospital will continue to operate out of its existing building until construction is complete by the fall of 2010.

Summer, 2008 – Sod turning ceremony
July 4 2008 – Tender awarded
April 2008 – Tender advertised
October 31, 2007 – Transfer of ownership from Saskatchewan Catholic Health Corporation (SCHC); name changed to Humboldt District Hospital
August 30, 2007 – Construction sign erected at new site
April 2005 – Funding for construction included in government’s capital budget
August 1999 – Government approves planning for new facility
April 1996 – Central Plains Health District forms committee to begin planning new facility.
1955 – Existing building constructed, with addition in 1967
1911 – St. Elizabeth’s Hospital founded by the Sisters of St. Elizabeth. Building constructed, with additions in 1919 and 1928
