# 2015-16 Budget Highlights Provincial Municipal Support

The 2015-16 Budget provides \$346.2M of direct provincial support to municipalities. This represents a decrease of \$48.4M or 12.3 per cent from the 2014-15 Budget and an increase of \$104.3M or 43.1 per cent from 2007-08 Budget. The 2015-16 decrease is largely a result of a \$50.0M reduction for the Regina Stadium Project.

Municipal Revenue Sharing accounts for the most significant portion of this funding at \$265.3M in 2015-16, an increase of \$8.3M or 3.2 per cent from the 2014-15 Budget. This is an increase of \$138.0M or 108.4 per cent from 2007-08 Budget – and is the largest grant ever provided to municipalities.

This funding includes only provincial funding to municipalities and as such, does not include federal funding that flows through the Ministry of Government Relations to municipalities.

## **MUNICIPAL REVENUE SHARING**

• Municipal Revenue Sharing (MRS)is based on 1.0 percentage point of Provincial Sales Tax (PST) revenue as reported in Public Accounts from two years prior. The following table shows MRS and the corresponding applicable PST for the 2015-16 Budget, previous years as well as the forecast for 2016-17.

- Total 2015-16 funding will be allocated as follows:
  - \$170.5M, or a \$5.3M increase, to urban municipalities;
  - \$75.0M, or a \$2.3M increase, to rural municipalities; and,
  - \$19.8M, or a \$0.6M increase, to northern municipalities.

### **INFRASTRUCTURE**

- Highlights of the \$31.7M in provincial support for municipal infrastructure includes:
  - \$16.0M for the Municipal Roads Strategy (Highways and Infrastructure);
  - \$7.7M for the Urban Connector Program (Highways and Infrastructure);
  - \$5.6M for the New Building Canada Fund (Government Relations); and,
  - \$2.3M for the Saskatchewan Infrastructure Growth Initiative (\$1.6M) and Saskatchewan Infrastructure Growth Initiative Renewal (\$0.6M) (Government Relations).

#### **OTHER FUNDING**

- Highlights of the \$49.2M in other funding for municipalities includes:
  - \$15.4M in policing grants (Corrections and Policing);
  - \$11.1M grant to Libraries (Education);
  - \$8.2M for Grants in Lieu of Taxes for municipalities and libraries (Government Relations);
  - \$6.0M to maintain grant funding for Urban Parks (Parks, Culture and Sport and Advanced Education);
  - \$3.5M for the Transit Assistance for People with Disabilities Program (Government Relations);
  - \$1.8M for the Discount Bus Pass Program (Social Services); and,
  - \$1.7M for the Making Community Rinks More Affordable Grant which provides each municipally operated rink in the province with a \$2,500 annual operating grant (Parks, Culture and Sport).

#### **Details of Revenue Sharing**

The following breakdown by pools includes revenue sharing commitments for the last eight years for the urban pool, made up of cities, towns, villages and resort villages; the rural pool made up of rural municipalities and organized hamlets; and the northern pool, made up of northern municipalities.
