Retail Store Permit RFP Process #4 Additional Information

In November 2015, Government announced changes that will see an expanded private liquor retail system in Saskatchewan. This includes the conversion of 40 government liquor stores to private opportunities and the addition of 12 new retail opportunities in underserved communities.

Although the initial announcement included a total of 52 retail opportunities, there will only be 50 opportunities awarded during the coming months. The City of Prince Albert declined to add an additional liquor retailer in that community and the existing liquor store in Melfort will continue to operate until 2019 when its current lease expires.

The 51 opportunities will be awarded through a Request for Proposal (RFP) process and successful proponents must also qualify for a commercial liquor permit.

KPMG has been engaged to ensure integrity of the RFP process. KPMG was also consulted during development of the RFP documents.

The first RFP process for retail store opportunities in Saskatoon and Regina began July 7. Deadline to submit proposals for the Regina and Saskatoon opportunities is Aug. 8.

Other information

As detailed in the RFP documents, there are a number of terms and conditions associated with Retail Store Permits. Some of these include:

Ownership of Multiple Retail Stores

In communities where more than one opportunity is being advertised (such as Regina and Saskatoon), a single operator cannot be awarded more than one of the available retail store permits.

As well, a single person or operator, or the directors, shareholders, employees of a person or operator, may operate multiple retail stores in Saskatchewan but will not be able to operate <u>all</u> the retail stores in a single community. (If a community has two retail store permits, the same operator cannot hold the retail store permit for both stores. If a community has three or more retail stores, a single operator can hold the retail store permit for all but one of the retail stores in that community).

Structure of Retail Store Permits

Retail stores operating in communities with more than 5,000 people, or in incorporated cities, will be required to operate as standalone businesses, not integrated within another business. While a retail store in a community with more than 5,000 people can be operated in conjunction with another business, it must be substantially separated from the other businesses and process all its transactions separately from the transactions of the associated business.

However, it is recognized that there are existing operators in such communities operating an 'integrated' retail model (ex. some city hotels/brew pubs sell alcohol for off-premise consumption from a location behind the bar, rather than a separate off-sale store). Such operations will be able to continue to exist as integrated facilities until the business is sold or transferred.

In communities with less than 5,000 people, which includes all 20 communities included in this fourth wave of RFPs, liquor retail sales can occur directly within an existing business. Liquor retail sales within an existing business (ex. hardware store, convenience store, etc.) is consistent with the current model of liquor retailers in small communities.

Moratorium

In order to provide some stability to the industry as Saskatchewan transitions to this new liquor retail system, there will be a two-year moratorium on the sale of retail store permits and/or relocation of existing retail stores. This does not apply to business owners who choose to relocate or sell their entire operation (as opposed to just the liquor retail portion of their business). The moratorium will be in effect when the 'level playing field' for all liquor retailers is implemented, expected to occur later this fall.

Employee involvement

In its November 2015 announcement, Government indicated that SLGA employees directly affected by the conversion of the 40 liquor stores would receive preferential consideration should they choose to apply for one of the retail opportunities. Proposals where such employees form all or part of the ownership of a proposed retail store will receive additional favour during the scoring process.
