First Nations and Métis funding

The 2019-20 Budget provides approximately \$211 million, an increase of \$9.5 million or 4.7 per cent from the 2018 19 Budget, for targeted program funding primarily for First Nations and Métis organizations or individuals. This funding excludes provincial expenditures that may be accessed by the general population, which also provides benefit to First Nations and Métis people. It does not include programming provided through school divisions, colleges or the Saskatchewan Health Authority.
