

# First Nations and Métis Funding 2022-23

The 2022-23 Budget provides approximately \$233.2 million for targeted program funding primarily for First Nations and Métis organizations or individuals. This represents an increase of \$39.6 million or 20.5 per cent. This funding excludes provincial expenditures that may be accessed by the general population, which also provide benefit to First Nations and Métis peoples. This only captures funding from executive government. It does not include school divisions, post-secondary institutions or the Saskatchewan Health Authority.
